Cleaning of the buildings and grounds areas will be assumed by the applicant under direction of the Trempealeau County Agricultural Society Inc. Costs of any repairs caused by undersigned party, deposit will be retained as for all or partial payment for repairs. Security deposit or balance of remaining damages to be paid will be mailed to applicant within 10 days following the event and inspection of premises. The undersigned assures competent adult supervision of the event, assumes all responsibility for personal liabilities and must obtain all necessary permits for said event. **A certificate of insurance is required, and must be on file with Trempealeau County Agricultural Society Inc. before the "Rental" will be accepted.**

All applicants must be approved by the Trempealeau County Agricultural Society Inc.

All applicants must provide at the time of application:

1. Rental agreement form
2. Security deposit check
3. Check for Facility Area/Building fees before any agreement will be made with applicant.
4. A credit card will need to be provided with matching ID (\$50/hour will be charged to the card for any cleaning incurred by fair staff)

Cancellation of event thirty (30) days or less prior to contracted date will result in loss of deposit fee.

Deposit amount will be \$200.
